2010 CRITERIA GUIDELINES

Application must be received by August 13, 2010

Open to Public: 9:00 AM -6:00 PM

Set-up begins: 7:00 AM

Tear Down: May not begin prior to 6:00 p.m, must be completed by 8:00 p.m.

Entry Fee: Option 1: Inside: \$40.00 (includes 1- 8 ft. table and 2 folding chair per entry fee)
Option 2: Outside: \$30.00 (Vendor will supply own tent, table and chairs)
Option 3: \$10.00 fee and vendor will donate 10% of profits to MMDA at conclusion of event

Fine Art: All art must be original work of the accepted artist, (oils, acrylic, color pencil, charcoal, etc.)
At least 50% of art must be for sale, except for special display items.

Artisan/Crafters: All work must be original creation of the accepted artisan/crafter. Items that appear to be purchased or manufactured will not be accepted for exhibit. Committee decision will be final. 100% of merchandise must be for sale except for special display items
